PULLMAN CITY CODE

The city of Pullman has codes to help keep your neighborhood a friendly place to live. Being aware of those codes will help you avoid violations, which can result in fines and mandatory court appearances. We summarize some of the most important codes below.

GOOD NEIGHBORS

Remember that College Hill is home for families and long-term residents, as well as students. We encourage you to get to know your neighbors. Wave, introduce yourself, consider hosting or attending a potluck or neighborhood event. We look forward to seeing you around the neighborhood!

► PRIDE OF PLACE

Trash Collection Pickup day on College Hill is Thursday. Call Pullman Disposal at (509) 334-1914 to set up required trash collection and to obtain recycling containers. (Pickup occurs early in the morning, so put out your trash on Wednesday night and put the empty container away within 24 hours after each collection.)

Recycle! Recycling is picked up curbside every other Thursday. Visit www.pullmandisposal.com to sign up for notifications, print a recycling schedule, and read FAQs and information about what can be recycled.

Helping Others Donate unwanted items to local thrift shops:

Did you know?

Leaving indoor furniture outside is prohibited. Putting glass, plastic bags, pizza boxes, garbage in recycling bins spoils the processing and all suffer the costs.

► THINKING OF OTHERS

We want you to have a good time on College Hill, but please be considerate of the your neighbors.

Loud noise is regulated 24/7 as a nuisance. Be considerate with your Parties, Music, or other potential Loud Noises. The fine for a first violation is \$100 and the second requires a court appearance. For more information, call (509) 334-0802.

► PARKING

Parking is regulated so be sure to observe the posted signs, which may indicate that parking is prohibited during WSU breaks or that a residential parking permit is required. For questions about parking, call (509) 334-0802.

Did you know? Parking in your yard outside of a designated driveway or parking area is prohibited.

► SIDEWALKS

Help us keep sidewalks in front of our houses safe by clearing debris, overhanging vegetation, snow, and ice.

Did you know? The city requires that sidewalks be cleared of snow & ice within 8 hours of daylight after snowfall.

► SAFE HOUSING

Safe housing is essential for everyone. If you believe there is an unsafe condition in your house or apartment, contact the owner, property manager, the city building inspector, or the city fire inspector.

Did you know? The number of people permitted to live in a housing unit at any one time is restricted.
